India's 2023 summit theme, "One Earth, One Family, One Future," reflects its commitment to sustainability and world unity. This theme is an appeal for cooperation in tackling global issues like poverty, digital inequality, climate change, and geopolitical tensions.

### **Importance of the Theme:**

- Sustainability and Climate Action:

- The goal of inclusive growth and equity is to close the gap between developed and developing countries.
- Future-oriented development promotes creativity, the uptake of new technologies, and crisis readiness.

## **Principal Areas of Attention:**

The summit placed a strong emphasis on raising funds for development and creating robust systems to withstand future health emergencies.

- Climate Change and Green Energy: By 2030, the summit sought to triple the world's capacity for renewable energy. To aid developing countries in their transition to green energy, India advocated for the phase-down of fossil fuels and the expansion of climate finance.
- 3. By enhancing internet connectivity, fostering digital literacy, and accelerating the uptake of digital payment methods and financial technologies (FinTech), digital transformation aims to reduce the digital divide.
- 4. Inclusive Growth and Global South Representation: The African Union was granted permanent membership by the G20, signifying a greater level of inclusion for underrepresented regions. India also supported development projects led by women and advocated for debt relief.
- Global Economic Stability: Leaders talked about bolstering global financial organizations such as the World Bank and IMF. Better trade agreements and cryptocurrency regulation were also

# **Important Occasions and Conversations Ceremony of Opening:**

With cultural performances and digital showcases. the summit got underway at Pragati Maidan's Bharat Mandapam. Sustainable and inclusive development is crucial, according to Prime Narendra Modi. Minister Prominent international leaders such as World Bank President Ajay Banga, UN Secretary-General António Guterres, and IMF Managing Director Kristalina Georgieva emphasized urgent global issues like economic recession risks, inequality, and the necessity of multilateral cooperation.

Global Economy and Sustainable Growth: The topics of discussion included supply chain stabilization, inflation control, and facilitating economic recovery in the wake of the COVID-19 pandemic. Supporting emerging economies through inclusive policies and debt restructuring was prioritized.

Climate Change and Environmental Sustainability: Nations reaffirmed their pledge to switch to green energy and become carbon neutral. One of the recommendations was to create a Loss and Damage Fund to assist nations that were at risk.

- South-South Cooperation: India utilized its presidency to draw attention to developing countries' top concerns, such as infrastructure development, sustainable finance, and fair trade.
